HOW HAS THE PROGRAMME ALLOWED YOU TO GROW AND DEVELOP?

I joined SMBC Aviation Capital on a one-year internship and during that time I took the opportunity to learn about the business. Following my internship, I was successful in my application to join the Graduate Programme. I am part of the 3-year programme, which allows me to gain a professional accountancy qualification while working on the Finance team.

The graduate programme offers a comprehensive structured induction programme and the opportunity to develop my skills on an on-going basis. Professional development is at the heart of the programme.

# TELL US ABOUT YOUR ROLE ON THE SMBC AC GRADUATE PROGRAMME?

I started in September 2019 working in the Customer Management Team. This involved liaising with airline customers on the day to day running of our aircraft. As the main point of contact for the airlines post-delivery of the aircraft, I was able to create strong relationships with our customers.

I also worked closely with our shareholders, Sumitomo Mitsui Finance & Leasing (SMFL) on our portfolio of aircraft that we managed on behalf of our Japanese investors. This allowed me to build a good understanding of our parent company's business, as well as affording me the opportunity to practice my Japanese language skills!

Being the main point of contact for customer queries also meant that I got to work with a lot of different teams within SMBC Aviation Capital during my graduate programme. This has been really valuable learning experience and gave me the opportunity to work with and get to know my colleagues from around the business.

# WHY WOULD YOU RECOMMEND OUR GRADUATE PROGRAMME?

The SMBC Aviation Capital graduate programme has given me great opportunities for career development.

In 2020, I was lucky enough to be able to spend 6 months in Japan on a language immersion programme as part of the graduate programme. This consisted of 3 months living and studying in Tokyo, and 3 months living with a Japanese host family in Fukuoka. This gave me the chance to vastly improve my Japanese skills, and provided me with the tools to work and do business through Japanese.

Following the successful completion of my programme, I was then given the opportunity to work in Japan at our offices in Tokyo as part of the Commercial Negotiation and Execution team and I have been living and working here for the past year (as part of a 3 year secondment) whilst furthering my career at SMBC Aviation Capital.
